1、在昆士兰大学与合作老师共同开展课题申报“企业与非营利组织协同的动力机制”。已经完成研究分工、研究技术路线、研究框架设计、和基本研究内容设计。同时，对“企业社会创业与政策”和“ESG 实践与政策”进行了研讨，为进一步开展案例研究提供思路和方法。

Conduct a project application at the University of Queensland on the Driving Mechanism of Collaboration between Enterprises and Non-profit Organizations. The research division of labor, research technology line, design of research framework , and design of basic research content have been completed. At the same time, discussions were conducted on "Corporate Social Entrepreneurship and Policy" and "ESG Practice and Policy", providing ideas and methods for further case studies.

2、在奥克兰理工开展了“企业风险控制”和“组织战略”课程的教学研讨，就合作开展“跨国企业合规经营战略决策机制”的研究达成了意向，并学习了该校博士研究生专业项目及其培养方案，就学生培养进行了研讨。

A teaching seminar on "Enterprise Risk Control" and "Organizational Strategy" courses was conducted at Auckland University of Technology, and an intention was reached to collaborate on research of "the Mechanism of Strategy for Multinational Enterprise Compliance ". The doctoral program and its training plan was also discussed.
